Personal data we process

MediluX BV processes your personal data because you use our services and/or because you provide us with these data yourselves.

Special and/or sensitive personal data we process

MediluX BV processes the following special and/or sensitive personal data of you only if necessary:

- social security number

For what purpose and on what basis we process personal data

MediluX BV processes your personal data for the following purposes:

- To deliver goods and services
- To be able to invoice goods and services
- To gain access for you for locations where work needs to be done
- To arrange your trip to the location where work needs to be done
- To be able to call or email you if this is necessary in order to provide our services
- To meet our legal obligations regarding the tax law.

Automated decision-making

MediluX BV does not make decisions on matters that can have (significant) consequences for individuals, based on automated processing.

How long we keep personal data

MediluX BV does not keep your personal data any longer than is strictly necessary in order to achieve the goals for which your data are collected. We use the following retention periods for the various (categories of) personal data:

Sharing personal data with third parties

MediluX BV only shares your personal data with third parties if this is necessary for executing the contract and to comply with any legal obligation.

To ensure the same level of security and confidentiality of your data, we have a processor agreement with companies that process your data on our behalf.

MediluX BV remains responsible for processing your data.

In addition, MediluX BV provides your personal data to other third parties, being clients or their legal representatives, if this is required to gain access to the work location. The type of these data depends on the conditions of the concerning client. We only do this with your explicit consent.

Cookies or similar techniques

MediluX BV does not use cookies or similar techniques.

View, modify or delete data

You have the right to view, modify or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by MediluX BV and you have the right to data portability. This means that you can submit a request to us to send your personal data to you or another organization mentioned by you.

You can send a request for access, modification, deletion, data transfer of your personal data, cancellation of your consent or objection to the processing of your personal data to administratie@medilux.com

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
